



Delegate Assembly Agenda

At this year's meeting, the Delegate Assembly will consider a proposal to increase association dues, three regular resolutions, and staff and committee reports on association activities. Also on the assembly's agenda is a one-hour open discussion of two topics: MLA structures for the twenty-first century and the future of scholarly journals. Documents associated with these agenda items can be accessed at the MLA Web site (www.mla.org/dameeting_agenda).

Since the 1 October deadline for submitting motions and regular resolutions has passed, only emergency resolutions may be added to the assembly's agenda. Members may submit emergency resolutions to the chair of the Delegate Assembly Organizing Committee up to twenty-four hours before the start of the assembly meeting. The last opportunity for submitting an emergency resolution comes at the Open Hearing on Resolutions at the convention (session 262). Please see the second section in Checklists for Submitting Resolutions (www.mla.org/submit_checklist) for information on submission requirements.

The assembly meeting will begin at 1:00 p.m. on Saturday, 7 January, in room 6B of the Washington State Convention Center. Members may address the assembly on any of the issues on the assembly's agenda. Because the assembly meeting is open-ended, latecomers will have a chance to join in important discussions of association policies.

2011 Election Results

Second Vice President. Margaret W. Ferguson (Univ. of California, Davis) was elected second vice president of the association. She will serve in that office from 9 January 2012 through the close of the January 2013 convention and will automatically become first vice president in 2013 and president of the MLA in 2014, serving in that office through the close of the January 2015 convention.

Executive Council. Lanisa Kitchiner (Howard Univ.), Lutz Koepnick (Washington Univ. in St. Louis), and Mecca Jamilah Sullivan (Univ. of Pennsylvania) were elected to the Executive Council for four-year terms (9 Jan. 2012 through the close of the Jan. 2016 convention).

Delegate Assembly. Twenty special-interest delegates and thirty-six regional delegates were elected to the assembly for three-year terms (9 Jan. 2012 through the close of the Jan. 2015 convention). Division and Discussion Group Executive Committees. Ninety members were elected to serve on division executive committees, and fifty members were elected to serve on discussion group executive committees. Most terms are five years (9 Jan. 2012 through the close of the Jan. 2017 convention). Presidential Address

The Presidential Address will take place at 6:45 p.m. this evening in the Sheraton Seattle (Metropolitan A, level 3). Executive Director Rosemary

G. Feal will report on the association's 2011 activities, and President Russell A. Berman will deliver the Presidential Address, announce the winner of the MLA Lifetime Achievement Award, and offer a statement of appreciation to Patricia Yaeger for her service as editor of *PMLA* (2006–11). The session is open to the public and will be followed by a reception. The awards formerly presented at this session will be given at the MLA Awards Ceremony at 6:45 p.m. tomorrow in Metropolitan A.

Guest Passes

A convention speaker may obtain a pass for a family member or friend who has no professional interest in language or literature to hear a paper given by that speaker. These passes must be requested at the MLA information center by the speaker on the day of the session. The speaker must provide his or her name, session details (session number, room, date, and time), and the guest's name. Passes may not be requested by guests of speakers, MLA members who have not registered for the convention, or by speakers for guests for any reason other than to see that person speak in a particular session.

All MLA members and members of the profession that the MLA serves are required to register in order to participate in or attend sessions. Please note that if you need a pass for an evening session you must obtain it before the information center closes.
